

Privacy Policy

What information do we collect?

We collect information from you when you fill out a contact form or send us an e-mail. When using our contact form, you will be asked to enter information such as your name and (e-mail) address. You may decline to share certain data with us, in which case we may not be able to provide to you all features and functionality of our website and/or customer service. You may, however, visit our site anonymously.

What do we use your information for?

 - To send periodic e-mails
- If at any time you would like to unsubscribe from receiving future e-mails, we include detailed unsubscribe instructions at the bottom of each email.

How do we share your information?

(a) Personally identifiable information: We will not rent or sell your personally identifiable information to others. We may store personal information in locations outside the direct control of Explore Lysefjorden (for instance, on servers or databases co-located with hosting providers). Any personally identifiable information you elect to make publicly available on our site, such as posting comments or reviews, will be available to others. If you remove information that you have made public on our site, copies may remain viewable in cached and archived pages of our site, or if other users have copied or saved that information.

(b) Non-personally Identifiable Information: We may share non-personally identifiable information (such as anonymous usage data, referring/exit pages and URLs, platform types, number of clicks, etc.) with third parties to help them understand the usage patterns for our website and services. Non-personally identifiable information may be stored indefinitely.
